
Dear well-wishers,

The state of Kerala is facing yet again another worst disaster. The relentless rains and landslides have caused unprecedented damage, leading to loss of lives, destruction of homes, and displacement of thousands of people. The situation is dire, and immediate intervention is crucial to mitigate further suffering and aid in the recovery process. According to our senior colleague and trained supporter, at least 270 people have been killed and hundreds are still missing after heavy rains triggered massive landslides. The landslides struck hilly areas in Wayanad district in the early hours of Tuesday when most residents were asleep. Several hilly regions in Wayanad district including Mundakkai, Chooralmala, Attamala and Noolpuzha villages, have been affected by a series of landslides, with most significant impact observed in Mundakai and Chooralmala areas.

The magnitude of this disaster has overwhelmed even the most prepared. The state urgently requires support in various forms including financial aid, medical supplies, hospital facilities, ambulances, food ration, clean drinking water, hygiene kits, raincoats, and shelter tents for the displaced. The local administration is doing its utmost to manage the crisis, but the scale of the disaster necessitates additional assistance from organisations and concerned individuals like you who can make a significant impact.

EFICOR has been in contact with local people trained by EFICOR over the years in the affected areas. EFICOR is intending to involve by providing support for 5000 families who are affected by flood by providing food, non-food & WASH items. We are hoping to provide relief worth Rs. 5000 per family for 5000 families in Wayanad district. South Zonal Implementer Mr. Harshan K Y has been deputed to visit these villages to assess the present situation and ensure support to the needy families.
